Community Legal Services

Ahakoia he ratonga **KORE UTU** ēnei, māhau tonu ngā utu kooti, pēnei me ngā utu tono (Court filing fees), aha rānei, e utu.

Ngā Paerau (Eligibility Criteria)

Ko ngā paerau mo ngā ratonga-a-ture:

- Me noho rānei koe ki te tonga o Tāmaki, Franklin me Otahuhu;
- Kaore ngā pūtea legal aid ka whakawhiwhia ki a koe;
- Kei raro iho to whiwhinga moni I ngā whiwhinga moni e whai ake nei:

\$33,800 (mo te tangata kotahi)

\$38,000 (1 dependent - tau/tamaiti rānei)

\$50,934 (2 dependents - tau/tamaiti rānei)

\$57,880 (3 dependents - tau/tamaiti rānei)

\$64,678 (4 dependents - tau/tamaiti rānei)

\$72,302 (5 dependents - tau/tamaiti rānei)

- Me whakarawe I to tuhinga taunaki I to wāhi noho
- Me whakarawe I to tuhinga taunaki I to whiwhinga moni.
